## ISTROUMA HIGH SCHOOL PARADE RULES

1. CONFIRMATION, INFORMATION AND INSTRUCTIONS ON LINEUP WILL BE **EMAILED** TO YOU THE WEEK PRIOR TO PARADE.
2. **Non-refundable** entry fee of \$50.00 payable to Istrouma High School. Organizations may submit more than one application for multiple entries; and/or to accommodate additional participants. No guaranteed entries received after **October 4, 2017** will be accepted).
3. All entrants must provide their own throws. Approved throws include individually wrapped candy, beads, cups and small toys. No sharp or dangerous objects allowed. The parade chairman must approve any other throw.
4. No alcoholic beverages allowed.
5. No profane or obscene signs, acts, objects or language allowed.
6. Organizations are asked to carpool to the check-in point @ Winborne Elementary School (St Charles Street entrance) in as few vehicles as possible to avoid congestion. Also, carpools should be waiting at Istrouma High School (38<sup>th</sup> West Parking Lot)\_to eliminate confusion at the parade's end. Floats will not be allowed to stop or unload during the parade.
7. After **line-up at 9:30 a.m.**, participants are asked to remain with their unit/vehicles until the parade starts.
8. Marching groups are asked to keep pace with the parade by using moving dance routines that will not create gaps and cause delays in the parade.
9. ATV, Golf Cart, and motorcycle riders must adhere to the mandatory helmet law. They must also exercise caution in operating their vehicles. No reckless driving will be tolerated before, during or after the parade. Vehicles must remain parked until the start of the parade. **Anyone under legal driving age must be accompanied by an adult.**
10. You must be at least **21** years of age, with a State Driver's License to drive a vehicle in the parade. **(cars, trucks, vans, etc.)**
11. **Istrouma High School** and the **East Baton Rouge Parish School Board/System** will not be held responsible for any damages or injuries caused by participation in the parade.
12. **MAXIMUM ENTRY HEIGHT** for ALL VEHICLES AND FLOATS IS 15'
